

The Rest & Digest Ayurveda Retreat - Program Terms of Purchase

This Agreement sets forth the terms of purchase from Occidental Nutrition (Mary Sheila Gonnella), Talya's Kitchen (Talya Lutzker), and Ayurveda Every Day with Talya.

By placing your Order with Talya's Kitchen and Occidental Nutrition (the "Companies" or "Company(s)"), by clicking "accept," or by using the Services, you agree to be bound by this Agreement. If you do not agree with these terms, you should leave the Company(s) website or the applicable purchase page and discontinue use of the Services immediately.

In these terms and conditions, "We/us/our" means Talya's Kitchen and Occidental Nutrition. "You/your" means you as a user of the Website and/or Customer of the Program/Services/Retreat.

The Services. The Company(s) provides services, education and information designed to support health and wellness, incorporating principles of Ayurveda, a longstanding, traditional body of wisdom designed to help people stay vibrant and healthy. Program/Retreat content may be delivered as follows: via retreat exercises, in-person teachings, bodywork, nutrition assessments, email, on-line through the program website, forum, or membership site, audio files, videos, PDF downloads, self-study program materials, webinars, coaching, masterminding, live events, workshops, or as otherwise indicated on your Order form page. If your purchase includes an online Program or Membership site access, you will use a unique username and password that should only be used by you to access the Content. Sharing log-in information, call-in numbers, passwords, and protected links with non-members is prohibited and will result in removal from the program.

The Rest & Digest Ayurveda Retreat: The Rest & Digest Ayurveda Retreat is a 7-day, guided and supported, nutrition and body education retreat rooted in the Ayurvedic system of heath and nutrition. It's delivered via a live, in-person, overseas retreat that includes in-person teachings based in modern nutrition, Ayurveda, and physiology, yoga classes, guided meditation, cooking classes, group coaching, various retreat exercises, and email. Retreat Tuition includes a travel-size wooden gua sha, custom abhyanga body oil, Rest & Digest Ayurvedic Evaluation, retreat booklet, pre-



retreat virtual gathering, and exclusive access to our Rest & Digest Ayurveda teachings.

Payment. Payment is required before beginning the retreat, as indicated on your Order form, and may be a one-time fee, or a monthly or other recurring fee, as applicable. Please check the details of your Order form or Order page for the information specific to your program. You agree to pay the amount agreed and not to cancel this transaction with your bank or credit card company. The Company(s) is not responsible for any overdraft charges, over limit charges, or NSF fees charged by your bank or credit card company. Fees for Services may be pre-paid or by installment, as indicated on your Order form. Failure to make an installment payment will result in suspension or termination of the Services. The Company(s) do not guarantee any specific results from use of the Services. The Company(s) do not make any representations or warranties as to specific outcomes or results.

Refund Policy. Please review the refund policy for your respective program, retreat, or purchase below:

- The Rest & Digest Ayurveda Retreat: We have poured blood, sweat and tears into building this program for you. We're confident that by participating in this program you will learn how to practice healthful, Ayurvedic principles that will nourish your body and improve your health. We also ask that you give your full commitment before you begin.
- If circumstances make cancelling your retreat necessary, you'll receive a refund less \$250 for cancellations up to January 31st, 2020. After January 31st, 2020, a 50% refund will be issued if space can be filled. Please note, when cancelling, you must cancel separately with Mar de Jade, as well as any airlines or related travel purchases. No refunds will be issued after March 6th, 2020.
